





Beverley Shepherd

Finance Director, Econ Engineering Ltd

Beverley Shepherd is the finance director of Econ Engineering Ltd; she joined the company in 2014 as company accountant before being promoted to finance director three years later. Econ Engineering Limited, based in Ripon, North Yorkshire, is the UK's leading manufacturer of gritters, de-icers, and snow clearance and highway maintenance vehicles. The company has grown significantly over the last few years and Beverley has made an outstanding contribution to the business's success.

Beverley returns to the Northern FD awards this year as a judge, following her successful award of Finance Director of the Year (£25 million to £100 million) in 2018 and Finance Director of the Year for Leadership in 2022.



Craig Tomkinson

Group Chief Financial Officer, Bopran Holdings (2 Sisters Food Group)

2 Sisters Food Group is one of the largest food manufacturers in the UK, turning over £3 billion and employing 18,000 people across 20 manufacturing sites across Europe.

Craig Tomkinson re-joined 2 Sisters in 2018 as group CFO, to execute a new strategy of focusing on its core fresh poultry and meals business. Since then, the group has executed eight disposals, realising over £700 million of enterprise value – most notably a sale of the Fox's Biscuits business to the Ferrero Group in 2020 for £246 million.

Over the last 18 months, the group has focused refinanced in the high yield bond market, and continued the turnaround of the core business, supplying poultry products and ready meals to customers including M&S, Aldi, Tesco, Lidl, Sainsburys, KFC, etc.

Craig returns to the Northern FD Awards as a judge this year, after previously winning the Best Northern Finance Director of a Company Over £100 Million in 2021.
